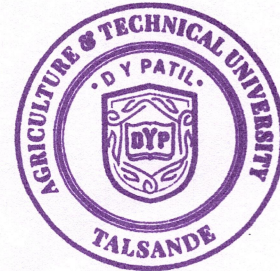
### **ACTION TAKEN REPORT**

## Internal Complaint committee Report

With the directives from Hon'ble Vice Chancellor, DYP-ATU and with reference to the complaint received as on 18/04/2023 from Ms. Ashwini B. Chougule, Assistant Professor of CSE, School of Engineering and Technology, DYP ATU, Talsande defined as "Complainant" against Dr. Sangram T. Patil, Associate Dean, School of Engineering and Technology, DYP ATU, Talsande defined as "Defendant" regarding sexual abuse and harassment by Associate Dean, the committee has investigated by listening both the parties, confirmed evidences and presenting report.

**Background:** Complainant joined DYP ATU on September 21, 2022 with the reference of defendant. Both complainant and defendant are known to each other before joining DYP-ATU as well as are relatives. Both accepted that they were having casual, in person and on phone conversations often.

### Complainant:

1. As per WhatsApp chat history presented as evidence by complainant, defendant asked to go for movies in the month of October 2022 and complainant denied. From the same evidence it is found that defendant complimented complainant for looking good and complainant replied back with the gesture as she find him as a father figure.
2. Complainant added further receiving calls on WhatsApp and in person in cabin asking to maintain relationship. Whereas, complainant has not provided any WhatsApp call history, also committee didn't found any evidence against in cabin conversations.

### Defendant:

1. Upon questing on evidences provided by complainant, defendant accepted that he messaged to her for movie and cleared his intentions by saying that it was general gesture and asked her because they are known to each other since years.
2. Defendant denied about the WhatsApp calls and in person cabin conversations. Defendant also shown his WhatsApp chat history with her in which nothing extra has been found objectionable rather than above evidences from complainant.
