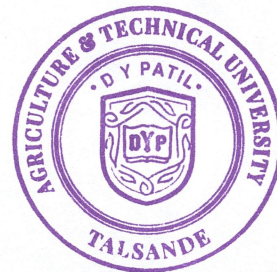

Registrar Dr. Jayendra Khot read the minutes of the previous meeting held on 16<sup>th</sup> of January and confirmed by all the members the same

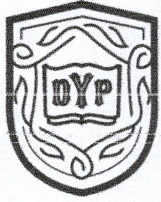
**2. To take note on Action taken reports of the last meeting and confirm the same.**
